## 3. Minutes of the last meeting

The minutes of the meeting held on  $4^{th}$  March 2013 were agreed, with the following amendment, and signed by the Chairman.

**2014**: Anniversary of World War I: It is planned to restore the War Memorial, to be completed by April 2014. It is hoped to obtain a grant from 'Sharing Heritage'. Cllr Davies is in the process of obtaining costings from stonemasons and will present these to fellow councillors, together with photographic evidence, before presenting to the funding authority.

# 4. Matters Arising from the Minutes

**Planning Enforcement – Haydens:** Cllr Kerridge reported that activity on the site has reduced to a level that would be acceptable with the permission the owner has. If there are any further problems the Environmental Health Officer should be contacted.

**2014**: Anniversary of World War I: Cllr Davies has obtained 3 quotes from stonemasons to carry out work on restoration of the War Memorial. It was agreed that the best quote was from Cormal Masonry at £2600 and this is the budget we should work to. Cllr Davies also produced extensive photographic evidence. A proposal will be drafted for submission to a relevant funding authority.

*Flooding at Capilano Corner:* It was reported that there were still problems with flooding. Cllr Rickhards agreed to investigate.

**SDC Grass cutting costs:** It was confirmed that the additional payment had been received.

**Pot Holes – Sambourne Lane:** Resurfacing work is scheduled and the pot holes will be repaired when this takes place.

*Fly Tipping:* More junk has appeared in the gateway in Wike Lane. Cllr Jones has reported it to SDC but it has not been collected. He will contact them again.
